Fund Objective

The investment objectives of ASBSN are to seek medium to long term capital appreciation of the Units through investment in the equity markets and to seek income opportunities by investing in high income yielding securities and interest-bearing instruments.

Market Review

The KLCI rose 2.6% month-on-month (MoM) to 1,576 in April in line with Asian market which Hong Kong and Singapore were up 7.4% and 2.1% MoM respectively. The local mid and small cap stocks outperformed the large cap, as the FBM70 gained 2.5%. Utilities and Healthcare were the best performing sectors, gaining 7.3% and 6.4% respectively. Finance and Construction, on the other hand, were the worst performing sectors, both losing 0.3%.

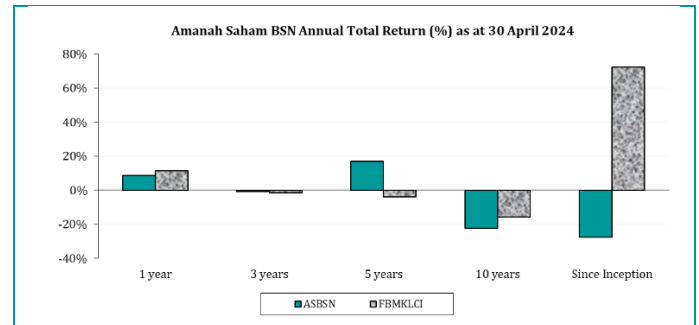
