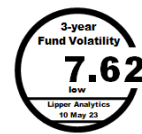




BSN DANA DIVIDEN AL-IFRAH



Fund Objective

The Fund seeks to provide consistent income* by investing in Shariah-compliant equities with attractive dividend** yield and/or potential dividend yield.

*Note: Distribution of income will be done by way of reinvestment into additional Units.

**Note: "Attractive dividend" refers to stocks of companies which have provided an average gross dividend of at least 3% for the past 3 years from the latest financial year.

Market Review

The FBM EMAS Shariah Index rose 0.2% in April, in line with the other indices in the region. Telecommunications and utilities were the best performing sectors with a return of 6.2% and 5.1% respectively. Foreign institutional investors were net sellers of RM0.3 billion while local institutional were net buyers. The index dropped 1.8% year-to-date to 10,737, one of the worst performing indices in Asia.

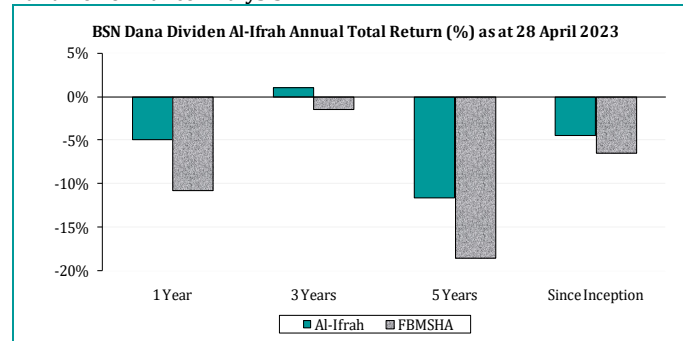

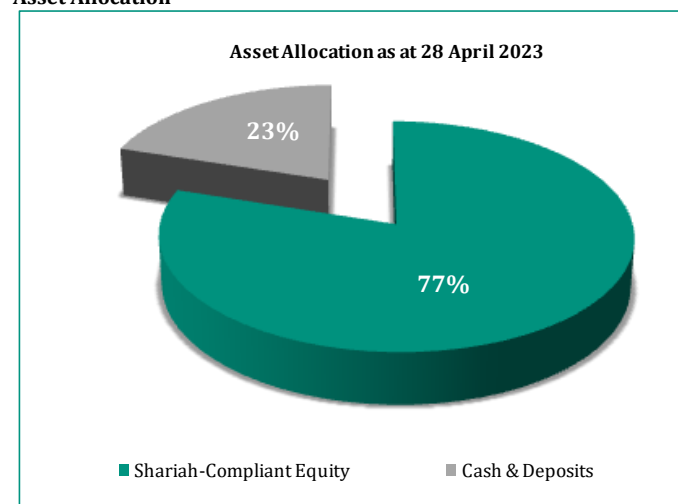
