Fund Objective

The Fund seeks to provide consistent income* by investing in Shariah-compliant equities with attractive dividend** yield and/or potential dividend yield.

*Note: Distribution of income will be done by way of reinvestment into additional Units.

**Note: "Attractive dividend" refers to stocks of companies which have provided an average gross dividend of at least 3% for the past 3 years from the latest financial year.

Market Review

The FBM EMAS Shariah Index climbed from its trough for the year to post 4.4% quarter-on-quarter rise in 3Q2023. Amongst the sectors that saw strong performance during the quarter were Properties (+27%), Energy (+16%) and Utilities (+15%). The 2Q2023 result season showed some improvement as misses-to-beats ratio narrowed to 2.2x from 4x in 1Q2023. The disappointments were centred around weaker consumer sentiments, higher operating costs and slower-than-expected recovery in the technology space. On a YTD basis, the index still closed in the negative territory.

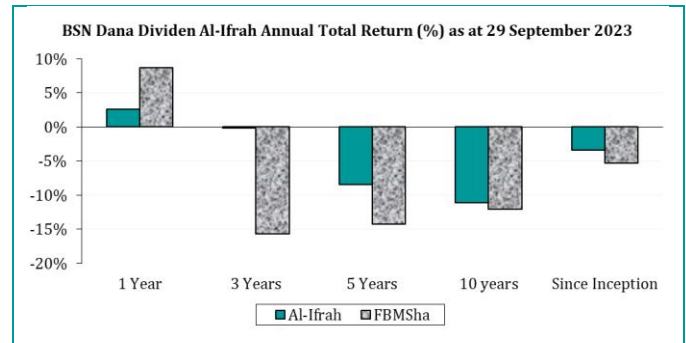

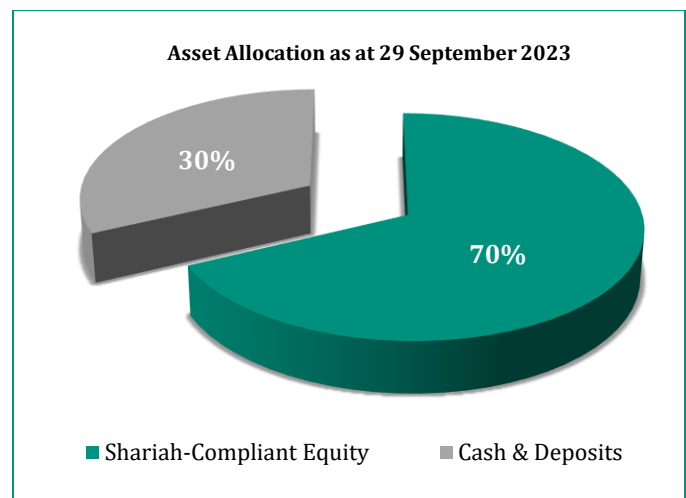
