

# BSN DANA WAKAF AL-IKHLAS

## **Fund Objective**

The Fund aims to provide investors with income and capital appreciation through a diversified portfolio of Shariah-compliant investments over medium to long term period.

The Fund also aims to facilitate investors who wish to channel part of their income distributions for wakaf purposes.

Any material change to the investment objective of the Fund would require the Unit Holders' approval.

## **Market Review**

The FBM EMAS Shariah Index recorded gains of 14.6% in FY2024 in line with the global market, pushed by the Utilities sector. Construction was the best performing sector, gaining 60.7% during the year, while Telco was the worst performing sector, losing 4.4% during the year.


