Any material change to the investment objective of the Fund would require the Unit Holders' approval.


Market Review

The FBM EMAS Shariah Index advanced 5.20% in July and inched up 0.1% year-to-date (YTD) to close at 10,952.72. The July gain was in tandem with the global equity market Property and Industrial were the best performing sectors as both jumped 12.0% and 7.5% in July respectively. On the other hand, the worst performing sectors were REITS and Transportation, gaining 0.0% and 1.3% respectively. Foreign institutional investors turned net buyers, reducing the YTD net selling to RM2.8 billion.


